🝃 Full Package Bonus

Members who participate in PE Partners' Liability, Property and Workers' Compensation programs are eligible for a full package bonus.

The bonus is paid in October for the prior fund year. Bonuses range from \$500 to \$10,000, depending on members' premiums.



👺 Dividend Program

For more than 20 years, PE Partners has declared an annual dividend to return excess surplus directly to members - not to outside stockholders or shareholders.

Qualifying members receive the dividend as a credit applied to their renewal premiums.



Grants

Public Entity Partners' grants program invests in training, education and equipment to help keep our members' employees safe and protect their resources. This program provides financial assistance to help members purchase essential safety and loss prevention items, as well as increase their knowledge of risk management and loss control techniques.

The program includes the Cyber Security Grant, James L. Richardson Driver Grant, Property Conservation Grant and Judy Housley Safety Partners Grant.



Scholarships

Scholarships are available to PE Partners' members to provide their employees with additional safety, liability and risk management learning opportunities.

Scholarships are offered for the PRIMA Institute, National PRIMA and Tennessee PRIMA, as well as the Legal and Liability Risk Management Institute for law enforcement personnel.



Property Valuations

Public Entity Partners provides property program members with valuations of the real properties they insure through us. The report provides replacement costs and actual cash values.



Risk & Insurance Symposium

The annual Risk & Insurance Symposium is a three-day educational and networking opportunity open to all Public Entity Partners' members and local agents.

Sessions expand attendees' knowledge and provide them with numerous risk management best practices. Several sessions offer CMFO credit hours.



△ Legal Hotline

Public Entity Partners' Legal Hotline is a free resource providing guidance for members with legal issues that could potentially turn into claims or lawsuits.

In addition, EHS Hero and HR Hero offer access to safety plans, resources for incident-specific training, current state and federal regulation, and numerous timesaving solutions for HR needs.



Member Workshops

Each year, PE Partners offers regional workshops to provide training to local governments.

Workshop topics include workers' compensation, employment practices liability, use of force by police agencies, creating a culture of civility, respectful workplace, managing risk through effective supervision, work zone safety/ flagging and numerous others.
